
## CIRCULAR

The MPSEB vide order-23 issued vide no. 01-01/IV/488 dated 29.05.2003 has decided to provide best possible treatment facilities to the employees who met with accident while on duty and delegated powers to the SE(O&M)/(City)/(EHT)/(T&C)/ concerned SE(Operation or Maintenance) of the Power Station/Project for sanction of an amount of Rs. 10,000/- to such employee to take care of financial hardship immediately on accident while on duty in case he is to be hospitalized. Such amount shall be later adjusted from his medical reimbursement bills.

The matter has since been reviewed by MPPTCL and it has been decided to delegate the powers for sanction of advance to the employees, who meet with accident while on duty, to the Additional Secretary of the Company as indicated below:-

- i. The advance shall be 75% of the estimated amount issued by the concerned hospital subject to maximum of Rs. 1,50,000/-.
- ii. The advance shall be sanctioned in instalments of Rs. 50,000/- based on the requirement of the treatment.
- iii. In case the cost of treatment exceeds 75% of the estimate or Rs. 1,50,000/- and the treatment continues, the reimbursement of further amount, exceeding (i) above, shall continue and shall be adjusted in the final medical reimbursement bill.
- iv. The advance shall be granted in serious cases of accidents while on duty on recommendation of Chief Medical Officer, MPSEB Hospital, Jabalpur.
